Purpose

This document provides information and an application for interested applicants to complete and submit for consideration for appointment to the Wyandotte Creek Groundwater Sustainability Agency (GSA) Advisory Committee (WAC). The Agency Board is responsible for these appointments as further described in the Joint Exercise of Powers Agreement Establishing the Wyandotte Creek GSA and the Agency's WAC Charter.

Deadline and Submittal

Applications are to be submitted to WyandotteGSA@gmail.com. The current deadline for applications is October 6, 2023; however applications will be accepted until the positions are filled.

Advisory Committee Overview

The Wyandotte Creek GSA's purpose is to secure groundwater sustainability for the Wyandotte Creek groundwater subbasin. The GSA intends to fill positions on its AC. The purpose of the WAC is to provide input and recommendations to the GSA Board on groundwater sustainability plan development and implementation as further described in the WAC Charter. The composition of the AC is intended to represent the beneficial uses and users of groundwater identified in the Sustainable Groundwater Management Act (SGMA).

Terms will be four-years (after initial staggered terms), and interested individuals can apply to become a member of the WAC.

There are a total of 6 at-large members. There are currently 3 at-large member vacancies. The GSA Board will appoint 3 at-large members. This application is for the following vacant seats:

- Domestic well users (2)
- Environmental representative (1)
- Business association representative (1)

In addition, WAC members will be appointed by each of the entities below:

1. Cal Water – Oroville (1)
2. South Feather Water and Power (1)
3. Tribal Representative(s)

Eligibility Requirements for Wyandotte Creek Advisory Committee Members

WAC members must live or work within or represent an organization with a presence in the Wyandotte Creek subbasin.

The GSA Board encourages candidates with experience and familiarity with groundwater and groundwater management. The GSA Board will also give preference to applicants who:

- have the backing of multiple organizations or individuals and / or;
- have experience working with diverse community-based groups;
- can represent the interests of disadvantaged populations or interests that are otherwise under-represented on the WAC.
